Good afternoon,

I wanted to reach out quickly to talk about some things that are going on right now that has delayed our prayer letter. We will get it out soon, but it has been delayed.

On Sunday November 1, I tested positive for Covid, and Jen tested positive on Tuesday. I had a slight fever and recovered from that within 12 hours or so. This past Sunday, Jen's oxygen dropped to 86% and we took her to a hospital in Longmont close to where we were staying in Wyoming.

Currently Jen is at North Central Medical Center in Greeley Colorado, and I am staying in a hotel there as well.

Jen has been on 4 liters of oxygen since Monday, and after a brief time out of bed this afternoon, she was bumped to 5 liters because she didn't recover quickly. She is being treated well by the nursing staff, with whom I have been in constant contact as her advocate. I am fighting for her as best I can remotely since I cannot be in the room or see her. She had a rough night last night with a panic attack and some disorientation.

Her kidneys look good and there is no crackling or wheezing in her lungs, so that is a praise. I am not sure if she has any pneumonia, but I plan to find out the next time I talk to the nurses. One of the questions that was overlooked during the three conversations I have had so far.

Please pray for my wife as she is struggling with her recovery. There really isn't anything I can do for her except video calling and prayer. I wish I could be there with her. I know it isn't the same, but I am also just 8 minutes away from the hospital. I would be happy to take your phone calls and or texts or even a Facebook message should you decide to reach out.

Many thanks to everyone who has reached out to us on Facebook and by text and phone calls. Your contact and prayers are so very much appreciated. Please pray for the nursing staff and doctors who are dealing with many Covid patients as well. They all have a heavy workload, and I can only imagine the stress they're under.

Thank you all for your prayer and financial support. God bless you all.
